### **General Information**

All conference events will take place on the campus of Davidson College, located 20 miles north of Charlotte, NC, at exit 30 on Interstate 77. Charlotte's Douglas International Airport is approximately 30 minutes from Davidson by car.

#### **Directions:**

From Airport:

Take Billy Graham Parkway north to I-85 North.

From I-85 North:

Exit onto I-77 North to Davidson, exit 30.

From I-85 South:

Take exit 55 (US Hwy 73); follow signs to Davidson (10 miles).

From I-40:

Exit onto I-77 South to Davidson, exit 30.

From I-77:

After taking exit 30, head east on Griffith St. Turn right at traffic light onto Main Street (campus will be before you). Turn left at light onto Concord Rd, then left into Baker Sports Complex parking lot.

Air Transportation:

Reduced conference airfares are available if you book your flight through Village Travel. Call Erika Reid at 1 (800) 284-5524 or (704) 892-9020 and identify yourself as a participant in the 19th Century Studies Conference.

**Ground Transportation:** 

Airport shuttle service to and from the airport is available from Lake Norman Limousine Service. One way fare of \$10, round trip of \$20, to be paid directly to driver, who will meet arriving participants in the baggage claim area. Local Transportation:

Mini-vans will circulate between Davidson College and the Cornelius Holiday Inn (7-10 minutes each way). Schedules given in final program.

Lodging:

The Holiday Inn in Cornelius (exit 28 off I-77) is offering a conference rate of \$69 per night, single or double occupancy. Rate includes continental breakfast in the hotel dining room. Call (704) 892-9120 before March 1 and mention the 19th Century Studies Conference; the code is NIN in case you are asked.

In addition, a very limited number of rooms are being held until 28 February at the picturesque Davidson Village Inn located in the town of Davidson.
